



Chairman's Report 主席報告

I am honoured to present my first report as Chairman of LEAP, an organization whose work in drug prevention education I have always greatly admired. This is an exciting year for all of us at LEAP as the organization embarks on a new chapter of its development.

LEAP moved to its new permanent office at Lai Yiu Estate in Kwai Chung in March 2012 and started operating in a brand new environment. As in the former headquarters, the 3,000 square foot premises include a Static Centre in which to deliver LEAP's Primary Programme to schools which cannot accommodate our mobile classrooms. After more than 15 months' suspension, the new Andy Lau Static Centre resumed service in mid April 2012 and served over 1,500 students in its first quarter of operation. We would like to thank the Hong Kong Jockey Club Charities Trust and Mr Andy Lau Tak Wah, LEAP's Health Ambassador, for funding the fitting out of the new office and Static Centre respectively.

Shortly before the office relocation, a new milestone was set when a LEAP team visited the Huizhen Academy in Ningbo and delivered LEAP's programmes in mainland China for the first time. We were delighted and encouraged that the response to LEAP's programmes was extremely positive. LEAP will continue to look for opportunities to inspire teachers and students in China to raise awareness of drug abuse while keeping its focus on Hong Kong.

It has not been long since I assumed the chairmanship of LEAP, yet I am fully aware of the importance of its role in the fight against drug abuse. Despite a gradual improvement in the local drug situation thanks to efforts at all levels of society, there is a growing trend of hidden drug abuse which is equally, if not more alarming. It is therefore more important than ever for LEAP to continue to provide drug prevention education programmes to both students and parents to help young people to stay away from drugs and nurture drug-free families. I am pleased to report that with the re-opened Static Centre, LEAP served a total of 88,598 students in the 2011/2012 academic year, up from 87,443 students in the previous academic year.

I took over the chairmanship of LEAP from Ms Quince Chong in August 2012. LEAP had the good fortune to work with Ms Chong whose vision and dynamism helped the charity go from strength to strength. We would like to thank Ms Chong sincerely for her dedication and generosity during her three-year term of office when she took every opportunity to support LEAP and encouraged others to do the same. Our thanks also go to Mrs Margaret Chan and Mr Yeung Chee Kong who resigned as directors during the year. We welcomed Ms Lucilla Leung, Mr Michael Lee and Mrs Pauline Chan to the Board.

Over the past 18 years, LEAP has been fortunate to have the support of many partners. LEAP is indebted to its two major sponsors, Swire and Cathay Pacific, who have been so generous and supportive for many years. We must acknowledge the invaluable loyalty of the Hong Kong Jockey Club Charities Trust, the Education Bureau and the Narcotics Division of the Security Bureau. Executive Director's Report

Overview

2012 was a very exciting year for LEAP, marked by continued growth and development. In the 2011/12 academic year, LEAP's preventive education programmes, which cater to Hong Kong children from the ages of 5 to 15, were delivered to a total of 88,598 students.

A major move for LEAP this year was the relocation to its new permanent home at Lai Yiu Estate, Lai King, in March 2012. As the Andy Lau Static Centre resumed service, LEAP also celebrated the launch of two new mobile classrooms. Amid all these major developments, LEAP reached 68,048 primary students, 15,612 secondary students and 4,938 special needs students in the 2011/12 academic year.

As reported by the Chairman, the local drug situation has continued to show improvement. The Action Committee Against Narcotics (ACAN) reported a decrease in the number of young drug abusers under 21 in 2012 compared to 2011. Yet, a trend of hidden youth drug abuse is also developing. Against this background, the Commissioner for Narcotics, Mrs Erika Hui, has stressed the need to remain vigilant and to monitor drug trends closely. Among the psychotropic substances abused, ketamine remained the most popular and 30% of abusers of ketamine are under the age of 21. While the number of reported abusers of most of other psychotropic substances fell, there was a rise of 8% in the number of reported methamphetamine ("ice") abusers.

Working with the Narcotics Division and other like-minded organisations, LEAP will continue to promote a healthy lifestyle from a young age while reinforcing understanding of the harmful effects of drugs. With a new Static Centre and an expanded fleet of eight mobile classrooms, LEAP is prepared to work with all sectors of the community to further its drug prevention mission by



reaching more students and encouraging more young people to develop a healthy lifestyle.

概要

總幹事報告


LEAP今年持續擴充,發展令人振奮。二零 一一至二零一二學年,LEAP總共為八萬八 千五百九十八名五至十五歲的本地學生提 供健康教育及預防藥物濫用課程。

LEAP 在今年的一個重要進程,是在二零一二 年三月搬遷到新設於荔景麗瑤邨的永久辦事 處。隨著劉德華生活教育中心重新投入服務, 以及兩所新的流動生活教育中心的啟用,LEAP 在二零一一至二零一二學年共服務六萬八千零 四十八名小學生,一萬五千六百一十二名中學 生和四千九百三十八名特殊學生。



如主席報告所言,本地吸毒情況持續有改善。 禁毒常務委員會報告顯示,與二零一一年相 比,二零一二年二十一歲以下年青吸毒者人 數有所下跌。然而,現在青少年吸毒有隱蔽化 趨勢。禁毒專員許林燕明女士亦強調要保持警 惕,密切監察濫用藥物的趨勢。氯胺酮是最常 被濫用的精神科藥物,百分之三十的氯胺酮 濫用者是二十一歲以下人士。雖然濫用其他類 型精神科藥物的人數有所下降,但甲基安非他 命(「冰」)的濫用者數目上升達百分之八。

LEAP 將繼續與禁毒處及其他相關組織攜手合 作,提倡從幼開始建立健康生活方式,同時 增加大眾對毒品禍害的了解。隨著新的劉德 華生活教育中心投入服務,以及流動課室增 加至八所,LEAP 將積極與社會各界合作,服 務更多的學生並鼓勵更多年青人建立健康生 活模式,進一步推動預防藥物濫用的工作。



Programme Review

The two-year Beat Drugs Fund project "New Era Drug Prevention Education Programme for Secondary Students" was completed in September 2012. LEAP produced new programme videos and resource materials for teachers to conduct follow-up activities with students. The project enabled LEAP to provide 864 classbased workshops reaching some 28,000 students in two years. The response from teachers and students was extremely positive. Teachers were pleased to see the new videos which they found realistic and useful in helping students to predict the risks in related situations. Meanwhile, students found the programme helpful in

increasing their awareness of the harmful effects of drugs and enhancing their skills and confidence to say "No" to drugs.

The Tobacco Control Office (TCO) granted HK\$1,399,960 for the provision of antismoking programmes to Primary 5 students in local schools for two years in August 2011. The project has been implemented for a year and the programme has been well received by teachers and students. LEAP is confident that the project will continue to operate successfully in the second year.

The project also invites students to join the

"Smoke Free, Starts with Me" campaign to further spread the antismoking message to their families and friends. The feedback from parents has been extremely positive and most of them are willing to establish a smoke-free family. LEAP looks forward to reaching more students as well as their families, to help promote a smokefree lifestyle in the community through our students, the "Smokefree Ambassadors".

Building on the success of the Primary Programme, the TCO has expanded its funding support to LEAP to provide free tobacco control programmes to junior secondary students in the 2012/13 academic year. The secondary programme, "Clearing the Smoke: The Quest for the Truth about Cigarettes", aims at increasing students' understanding of the dangers of smoking and the marketing strategies of tobacco companies, as well as helping them to develop effective skills to deal with peer pressure.



為期兩年的禁毒基金計劃「新紀元中學 藥物教育課程」已於二零一二年九月完 成,LEAP製作了全新的影片教材以及教學 資源,讓教師在生活教育活動計劃課程後 進行跟進活動。於兩年期間,LEAP總共開 辦了八百六十四節工作坊,服務約二萬八 千名學生,教師和學生的反應非常正面。 教師們很滿意新攝製的影片教材,認為內 容具真實性,能有效地幫助學生預計在各 種不同情境下的濫藥風險。同時,學生認為

> 課程可幫助他們增加對毒品 害處的認識,提高他們在面 對毒品誘惑時説「不」的自 信和技巧。

> 二零一一年八月,衞生署 控煙辦公室(控煙辦)撥 款港幣一百三十九萬九千 九百六十元資助LEAP為本 地小學五年級學生提供為 期兩年的控煙課程。課程 開至今一年,獲得教師 和學生的好評,我們有信 心該課程的第二年運作將 會繼續取得良好成績。

此外,學生同時也獲邀參加「無煙,由我 做起」運動,向他們的家人和朋友傳播無 煙訊息。家長的回應非常積極,他們大多 都願意建立一個無煙家庭。LEAP期望能服 務更多的學生以及他們的家庭,透過幫助 學生成為「無煙大使」推動無煙生活方式。

在小學課程的成功基礎上,控煙辦在二零 一二至二零一三學年擴大對LEAP的資助範 圍,為初中學生提供免費控煙課程「吸煙 多面睇」,旨在提高學生對吸煙的禍害和 煙草公司推銷策略的了解,並幫助他們建 立有效技巧以面對朋輩壓力。



Programme Development

The LEAP team carried out a complete review of its primary programmes in 2012 and revised some of the programme materials. In view of the increase in the number of reported cases of methamphetamine ("ice") abusers, the content of the Year 6 Chinese programme has been updated to include information on the harmful effects of using "ice". With increasing concerns about cyber safety and Internet addiction, the English "Cyberchoices" programme has been modified to accommodate students in different year grades. The content of the English primary programmes has also been revised to integrate better with the International Baccalaureate Primary Years Programme.

LEAP has been working proactively with schools to help promote the Education Bureau's Healthy School Policy (HSP) which aims to establish a healthy learning environment for students. Recognizing the importance of enhancing students' mental health, a new extension programme on exploring emotions is being developed for students in Primary 3 and Primary 4. The aim is to help students to acknowledge different feelings, and guide them to express and handle their emotions.

To complement our message of healthy living and to support schools in building a healthy learning environment for their students, LEAP produced panel boards with related quiz questions covering topics such as nutrition, exercise, medicine, tobacco, alcohol and psychotropic drugs. Schools are encouraged to use these resources to conduct health–related activities.



課程發展

在二零一二年,LEAP的小學課程進行了全 面檢討,並為部分課程教材進行修訂。由 於濫用甲基安非他明(「冰」)的個案上 升,小學中文六年級課程的內容已增加 濫用「冰」毒的害處。隨著社會對網絡安 全和網絡成癮問題越趨關注,英文課程 「Cyberchoices」的內容也作出修訂,以切 合不同年級學生的需要。而小學英文課程的 內容也進行了修改,以能更好地配合「國際 文憑小學課程」。

LEAP一直積極地與學校合作,推動教育 局提倡的「健康校園政策」,幫助學生營 造一個健康學習環境。我們明白到提昇學 生心理健康的重要性,故特別為小學三及 四年級學生設立延伸課程,以探索情緒為 主題,課程目標是幫助學生認知不同的感 受,引導他們表達和處理自己的情緒。



為配合我們的健康生活訊息,及支持學校 為學生建立一個健康的學習環境,LEAP特 別製作了一套展板,主題包括營養、運 動、醫藥、煙草、酒精和藥物,配合簡單 問答題目,以鼓勵學校借用這些資源來進 行健康教育活動。

在二零一二年,LEAP的特殊教育課程惠及 近五千名特殊學校學生。我們十分感謝香 港賽馬會慈善信託基金「香港賽馬會社區 資助計劃」捐助港幣一百六十六萬元,於 二零一二年起繼續為LEAP特殊教育課程提 供三年資助,並資助開辦一個全新課程單 元,以幫助特殊學校的學生認識到安全的 重要性及建立安全的習慣。

Our Special Needs Programme benefited close to 5,000 students at special needs schools in 2012. LEAP is grateful to the Hong Kong Jockey Club Charities Trust for granting a total of HK\$1.66 million and extending the Community Project Grant for the Special Needs Programme for another three years from 2012. A further grant will enable the development of a new unit to help special needs students be aware of the importance of safety and help them establish safety habits.


The Parent Programme which aims to equip parents with the knowledge and skills to build a happy, harmonious and drug-free family continues to be well received by schools and parents. New topics on handling children's emotions and improving their social skills are being developed to provide further support to parents.

The Grand Opening of LEAP's New Home

LEAP celebrated the official grand opening of its new office premises and the new Andy Lau Static Centre on 9 November 2012. Among our 160 guests were Mrs Erika Hui, Commissioner for Narcotics; Mr Michael Lee, Steward, Hong Kong Jockey Club; and Mr Andy Lau, LEAP's Health Ambassador who officiated at the opening ceremony with Ms Chitty Cheung, LEAP's Chairman.

LEAP relocated to its new permanent home at Lai Yiu Estate, Lai King on 15 March 2012. The 3,200 square foot office is well fitted out for our expanding team. As in our former home, there is also the Andy Lau Static Centre in which to deliver LEAP's Primary Programme to schools which cannot accommodate our mobile classrooms on their premises.

LEAP would like to thank the Hong Kong Jockey Club Charities Trust and the Andy Lau Charity Foundation Limited again for their grants of HK\$3.1 million and HK\$1.1 million for the fitting out of the office and the Static Centre respectively.





LEAP 新辦事處開幕

二零一二年十一月九日是一個值得慶祝的 日子,LEAP「新辦事處暨劉德華生活教育 活動中心開幕典禮及流動生活教育中心啟 用儀式」於當日隆重舉行,出席嘉賓逾一 百六十多人,揭幕禮由香港特別行政區禁 毒專員許林燕明太平紳士、香港賽馬會董 事利子厚先生,以及生活教育活動計劃健 康大使劉德華太平紳士,聯同LEAP主席張 鳳婷女士主持。

LEAP於二零一二年三月十五日遷往新設於 荔景麗瑤邨樂瑤樓地下的辦事處,新辦公 室佔地達三千二百平方尺,足夠應付員工 隊伍的擴展。新辦事處與舊址一樣,設有 劉德華生活教育活動中心,為未能容納流 動課室的學校提供小學課程。

我們十分感謝香港賽馬會慈善信託基金資助 港幣三百一十萬元作新辦公室的裝修工程及 劉德華慈善基金會有限公司資助港幣一百一 十萬元作固定教育中心的裝修工程。





We are also grateful to Swire Properties for providing us with a temporary office in Westlands Centre, Quarry Bay from the end of 2010 when LEAP had to leave its former office on Stubbs Road due to redevelopment of the site.

Launch of New Mobile Classrooms

On LEAP's grand opening day, 9 November 2012, LEAP also launched two new Life Education Centres (LECs), one a replacement and the other a new addition to the fleet. Thanks to a grant of HK\$3.1 million from the Hong Kong Jockey Club Charities Trust, LEAP now has a fleet of eight mobile classrooms. At the commissioning ceremony of the classrooms, Mr Michael Lee, Steward, Hong Kong Jockey Club and Mr Douglas So, Executive Director, Charities, Hong Kong Jockey Club, handed over a symbolic key to Mr Andy Lau, LEAP's Health Ambassador and Ms Chitty Cheung, our Chairman.

The two new mobile classrooms are the seventh and eighth LECs sponsored by the Hong Kong Jockey Club, which since 1993 has donated a total of almost HK\$24 million to LEAP. LEAP would like to thank the Hong Kong Jockey Club Charities Trust sincerely for its long-time and continuing support.

The smooth daily operation of our mobile classrooms is also due to the support of many other sponsors. LEAP would like to thank Dah Chong Hong for providing technical support; and towing companies Eastern Worldwide Co. Community Involvement

Caring Company Scheme

In 2012, LEAP nominated eight companies for the "Caring Company Scheme", which recognizes private companies that demonstrate good corporate citizenship. The nominated companies, all long-term supporters of LEAP, were: Another Factory Ltd, Cathay Pacific Airways Limited, Dah Chong Hong (Motor

Overseas Missions

Teaching in Mainland China

A 5-member LEAP team led by its Executive Director and Deputy Director visited the Hui Zhen Academy in Ningbo in March 2012. During the four-day visit, three LEAP educators delivered our Primary Programme to almost 300 students at the Hui Zhen Academy, marking the first

time that LEAP's programmes have been delivered in China. Although the sessions could not be conducted inside LEAP's unique mobile classrooms, the response was extremely positive. Students participated actively in class, while the teachers had the highest praise for the programme.

This exchange opportunity offered our educators first-hand experience of teaching in China. LEAP thanks its director Mrs Tammy Fan for liaising with the Academy, and its major sponsor, Cathay Pacific, for sponsoring the team's flights for the visit.

Students from Hui Zhen Academy have visited LEAP every summer since 2008 and participate in our anti-smoking programme. In 2012, a group of Year 10 students from the Academy visited LEAP's Static Centre to attend our tobacco control programme on 7 August. The 36 students were accompanied by 7 teachers during a one-week trip to Hong Kong as part of their summer English programme. 交流活動

The 6th Cross-Strait Conference on Tobacco Control

第六屆「兩岸四地煙害防制交流研討會」

LEAP participated in the 6th Cross-Strait Conference on Tobacco Control, held from 4 to 6 November 2012 in Nanjing, China. The conference focused on reviewing tobacco control measures and interventions. There were some 350 participants, mostly from governmental departments, academic institutions, hospitals and non-governmental organizations from



Mainland China, Hong Kong, Macau and Taiwan. Hong Kong was commended as very successful in tobacco control and a role model for Mainland China to follow, thanks to the coordinated efforts of the government and different sectors of the community.

The Hong Kong Council on Smoking and Health (COSH) celebrated the 30th anniversary of tobacco control in Hong Kong on 9 October 2012. LEAP will continue to cooperate consistently with COSH and like-minded organisations in its efforts to make Hong Kong a smoke-free city by 2022.

VIP Visits

Two representatives from the Zonta Club of Hong Kong, outgoing President Bonnie Kwan Huo and Kathleen Yip, JP, visited a LEAP class in action at SKH Kei Fook Primary School on 28 May 2012. The school was one of those benefiting from a grant of HK\$150,000 from the Zonta Club of Hong Kong. The sponsorship enabled schools hitherto unable to participate in LEAP's programmes to experience the interactive sessions. LEAP will continue its efforts to deliver essential health messages to students, as well as helping them to build up self-confidence so that they may resist negative influences and temptation and stay away from drugs.

LEAP - Who We Are 生活教育活動計劃

Life Education Activity Programme (LEAP) is a registered charity that provides internationally recognized health awareness and drug prevention programmes for primary and secondary schoolchildren. It helps them establish a healthy lifestyle and become aware of the dangers of drugs, including cigarettes and alcohol. LEAP's programmes are endorsed by the Hong Kong SAR Government's Education Bureau and Narcotics Division of the Security Bureau.

Life Education originated in Australia. The first Life Education Centre was established in 1979 by the Reverend Ted Noffs in Sydney, Australia. The concept spread throughout Australia and then internationally. Today Life Education operates in Australia, New Zealand, Hong Kong, Macau, Thailand, Indonesia, the UK, Hungary, Finland, Cyprus, Barbados and South Africa. 生活教育活動計劃(LEAP)是一個註冊慈 善機構,專為中、小學的學生提供一套國 際認可的健康教育及預防藥物濫用課程, 旨在讓他們明白到健康生活的重要及濫用 藥物的危險。課程獲教育局及保安局禁毒 處認可。

生活教育概念源於澳洲,首間生活教育中 心由Ted Noffs牧師於一九七九年在澳洲悉尼 創辦,之後此概念傳遍澳洲,並擴展至世 界各地。時至今日,生活教育已在澳洲、 新西蘭、香港、澳門、泰國、印尼、英 國、匈牙利、芬蘭、塞浦路斯、巴巴多斯 及南非運作。





LEAP was founded in Hong Kong in 1994. Our primary programme is taken to schools in specially designed mobile Life Education Centres (LECs), which can be driven all over the territory. LEAP now operates eight mobile centres and one static centre, as well as a secondary school programme. Our programmes reach some 90,000 schoolchildren annually, including 5,000 students with special needs. In 2006, LEAP launched "Safe and Successful", a programme which aims at equipping parents with skills to help their children establish correct values and to prevent substance abuse.

The LECs are designed to provide a relaxed environment for youngsters to enjoy the programme and become involved in discussions and role-play. Our specially trained educators make use of a modern audio-visual system, illuminated models of the human body, a 'talking brain' and games in the delivery of the programme. LEAP mascots Harold the Giraffe and Holly the Horse reinforce healthy living messages by talking and singing with the children. Our aim is to provide a step-by-step approach to learning about the body and how drugs affect it. Role-play helps develop social competency skills that enable children to make responsible decisions and to say 'No' to drugs without losing friends or face.

LEAP has its own training centre, where our educators undergo intensive training to deliver and direct the programmes. LEAP 於一九九四年在香港成立,以設計獨 特之「流動生活教育中心」將生活教育課 程帶進全港各區的小學。現時已有八所流 動生活教育中心、一所固定教育中心及中 學課程同時運作,每年為約九萬名學生提 供服務,包括五千名特殊學校的學生。二 零零六年,LEAP 更推行「新一代健康成長 錦囊」的家長教育課程,以裝備家長協助子 女建立正確的價值觀,抗衡藥物的引誘。

生活教育中心設計新穎獨特,為學生營造 輕鬆愉快的學習環境。受過特別訓練的教 育幹事們,利用中心內的先進影音器材、 會發亮的人體模型、會説話的腦袋及各式 互動遊戲授課。而LEAP的吉祥物「長頸鹿 哈樂」及「小馬凱莉」更會在課程期間跟 學生説笑及唱歌,從而進一步鞏固健康訊 息。LEAP透過循序漸進的教學方式,讓學 生認識人體的結構及藥物對它的影響;而角 色扮演更能協助學生建立社交技巧,懂得 如何作出正確的抉擇,有信心地拒絕煙酒 等藥物並同時保存自尊及友誼。

此外,LEAP 特設訓練中心,為教育幹事提 供嚴格訓練以傳授及策劃課程。

Notes to the Financial Statements 帳項附註

FOR THE YEAR ENDED 31 DECEMBER 2011

1. GENERAL INFORMATION

The Company is a registered charity, incorporated in Hong Kong with liability limited by guarantee. The address of its registered office is Unit 107-113, G/F., Lok Yiu House, Lai Yiu Estate, Kwai Chung, New Territories, Hong Kong.

The Company was engaged in providing educational courses during the year.

2. ADOPTION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS

In the current year, the Company has adopted all the new and revised Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") that are relevant to its operations and effective for its accounting year beginning on 1 January 2011. HKFRSs comprise HKFRS; Hong Kong Accounting Standards ("HKAS"); and Interpretations. The adoption of these new and revised HKFRSs did not result in substantial changes to the Company's accounting policies and amounts reported for the current year and prior years.

3. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared in accordance with HKFRSs issued by HKICPA, accounting principles generally accepted in Hong Kong and the applicable disclosures required by the Hong Kong Companies Ordinance.

These financial statements have been prepared under the historical cost convention.

The preparation of financial statements in conformity with HKFRSs requires the use of certain key assumptions and estimates. It also requires the directors to exercise their judgements in the process of applying the accounting policies.

The significant accounting policies applied in the preparation of these financial statements are set out below.

(a) Property, plant and equipment

38

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. All other repairs and maintenance are expensed in the income and expenditure account during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less residual

values over the estimated useful lives on a straight line basis. The principal annual rates are as follows:

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting date.

(b) Resale items

Resale items represent souvenirs purchased for resale and are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs necessary to make the sale.

(c) Trade and other receivables

Trade and other receivables are non-derivative financial assets with fixed or determinable payments that are not quoted on an active market and are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less allowance for impairment. An allowance for impairment of trade and other receivables is established when there is objective evidence that the Company will not be able to collect all amounts due according to the original terms of the receivables. The amount of the allowance is the difference between the receivables' carrying amount and the present value of estimated future cash flows, discounted at the effective interest rate computed at initial recognition. The amount of the allowance is recognised in income and expenditure account.

Impairment losses are reversed in subsequent periods and recognised in the income and expenditure account when an increase in the recoverable amount of receivables can be related objectively to an event occurring after the impairment was recognised, subject to the restriction that the carrying amount of the receivables at the date the impairment is reversed shall not exceed what the amortised cost would have been had the impairment not been recognised.

(d) Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value.

(e) Other payables

Other payables are stated initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(f) Revenue recognition

The Company relies on sponsorship from major corporations to cover the majority of the costs of running its programme. Sponsorship and Educator subsidies are recognised as income evenly over the periods specified by the donors. Amounts relating to future accounting periods are shown in the balance sheet as advance funding. Other income reflects the results of fund raising for capital equipment and future contingencies and is recognised upon receipt.

Interest income is recognised on a time-proportion basis using the effective interest method.

(g) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to end of the reporting date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Pension obligations

The Company contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Company and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to income and expenditure account represents contributions payable by the Company to the funds.

(iii) Termination benefits

Termination benefits are recognised when, and only when, the Company demonstrably commits itself to terminate employment or to provide benefits as a result of voluntary redundancy by having a detailed formal plan which is without realistic possibility of withdrawal.


(h) Impairment of assets

At the end of each reporting period the Company reviews the carrying amounts of its tangible assets except resale items and receivables to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of any impairment loss. Where it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset or cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in the income and expenditure account, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

(i) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Company has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

4. FINANCIAL RISK MANAGEMENT

The Company's activities expose it to a variety of financial risks: liquidity risk and interest rate risk. The Company's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Company's financial performance.

(a) Liquidity risk

The Company's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.

(b) Interest rate risk

The Company's exposure to interest-rate risk arises from its bank deposits. These deposits bear interest at variable rates varied with the then prevailing market condition.
