Chairman's Report 主席報告

The 2015/16 academic year was a busy and exciting one for LEAP, as the team prepared for a revision of the entire LEAP experience for students attending its drug prevention programmes.

LEAP served a new record of 107,730 students during the 2015/16 academic year as it strived to exceed the 100,000 student milestone set the previous year. Of these, 84,333 were primary students, 18,537 secondary students and 4,860 students with special needs. With a recent surge in the primary student population, we were pleased that we continued to reach 25% of this sector, our core target.

Thanks to the generosity of the Hong Kong Jockey Club Charities Trust, LEAP extended Augmented Reality (AR) and Kinect technologies to more mobile classrooms and its in-class programmes during the year. When the two new replacement mobile classrooms for our Special Needs programme and Chinese programme come into operation in early 2017, LEAP's entire fleet will be ready to provide an exceptional learning experience combining technology, fun and knowledge for students.

LEAP is aware that it is imperative to keep abreast of contemporary society, trends and problems. In addition to introducing the latest teaching technologies, we embarked on an exciting renewal of our primary programme. The revamp is making good progress and trials were conducted at several schools during the year. By autumn 2017, LEAP will have six brand new programmes for Primary 1 to Primary 6 students.

This year, we celebrated the award of the Bronze Bauhinia Star (BBS) to our Health Ambassador, Andy Lau Tak Wah. Mr Lau, who has helped LEAP promote its preventive drug programmes since 1996, received the award for his meritorious community service. The honour is a welldeserved recognition for Mr Lau who has given his best in both his profession and philanthropy throughout his career. Meanwhile, we were equally proud of our Macau counterpart which opened its new, innovative and multifunctional education centre in June 2016.

Helping to prevent children and young people from smoking is an important part of LEAP's mission. LEAP continued

承蒙香港賽馬會慈善信託基金的慷慨資助,LEAP 於本年度把擴增實境(AR)和 體感(Kinect)教學科技應用到更多流動 課室及班房課程。到二零一七年初,當兩 所分別為特殊教育課程及小學中文課程而 替換的全新流動課室正式啟用後,LEAP 的流動課室隊伍將會完成全面升級,一致 可為學生提供一個科技、樂趣和知識兼備 的獨特學習體驗。

LEAP 明白到我們的服務必須緊貼時代發展趨勢和社會問題,除了引進最新教學科技外,我們亦積極推行小學課程改革。課程改革工作於本學年度進行得如火如荼,新課程已經於多間學校開始進行試教。到了二零一七年秋季,LEAP將會為小學一至六年級學生提供六個全新的課程。

我們衷心祝賀 LEAP 健康大使劉德華先生 於年內榮獲香港特別行政區政府頒授銅紫 荊星章(BBS),以表彰他在社會服務的 貢獻。劉先生從一九九六年開始已一直協 助我們推廣預防藥物濫用課程,他不論在 個人事業及慈善工作上均作出了傑出的貢 獻,獲得授勳乃實至名歸。另外,LEAP 的緊密合作夥伴澳門健康生活教育所設立 的健康生活教育中心,已於二零一六年六 月正式啟用,內裏設有各種創新和多功能 的教育設施,對此我們為澳門健康生活教 育深感自豪。 to work closely with the Tobacco Control Office (TCO) to offer sponsored smoking prevention programmes to primary and secondary students during the year. These have received overwhelming response from schools and students since the partnership started in 2011 and are still much in demand. In the 2015/16 academic year, TCO's funding enabled some 9,500 primary and close to 8,000 secondary students to benefit from LEAP's anti-smoking programmes.

Communication of LEAP's messages to a wide audience depends on the continuing generous support of likeminded organizations. Building on the success of the "LEAP without Boundaries" project that started in September 2014, we are pleased to announce the launch of the project's second phase. As before, matching gifts from Lee Hysan Foundation and Chow Tai Fook Charity Foundation will allow up to 4,500 students and 200 parents from a total of six schools to enjoy LEAP's drug prevention programmes gratis for six years from September 2016.

In September 2015, Ms Rainy Chan resigned from the Board. LEAP would like to thank her for her contribution to helping the young people of Hong Kong. We welcomed to the Board Mr Nick Rhodes, who joined us in December 2015. Mr Rhodes has been associated with LEAP since the charity first started its partnership with Swire and we are very pleased that he has joined us.

Over the past 22 years, LEAP has been fortunate to enjoy the loyal support of many friends and supporters. We are indebted to our two long-time major sponsors, Swire and Cathay Pacific Airways; as well as the Jockey Club Charities Trust, the Education Bureau, the Narcotics Division of the Security Bureau and the Tobacco Control Office of the Department of Health. We are grateful to Lee Hysan Foundation and Chow Tai Fook Charity Foundation; towing companies Eastern Worldwide Co. Ltd, Sun Hing Group of Companies, Orient Trucking Ltd and A & S Logistics; and RSM Hong Kong and Dah Chong Hong. Special thanks go to our Health Ambassador, Andy Lau Tak Wah and our Life Buddy, Vivienne Tam. We would also like to extend our warmest gratitude to all the teaching professionals, students and volunteers for their ongoing trust in LEAP.

Executive Director's Report 總幹事報告

Overview

The 2015/16 academic year was an exciting and busy year with several major capital projects in full swing at LEAP.

Our drug prevention education programmes, which cater to students from the ages of 5 to 15, were delivered to a record number of 107,730 students during the school year. Of these, 84,333 were primary students, 18,537 were secondary students and 4,860 were special needs students. Thanks to the tireless efforts of the LEAP team, LEAP continued to achieve its strategic goals. In addition to reaching 25% of primary students, LEAP also managed to surpass its goal of reaching 10% of the secondary population, in fact reaching 11%.

LEAP has made great progress in the last few years, expanding in both scope and size. In light of the recent surge in the primary population, LEAP will strive to reach even more students through measures to enhance cost efficiency while putting a hold on further expansion for the moment, allowing the team to take stock of its experiences.



The project to retrofit all our classrooms and in-class programmes with the latest teaching technologies was completed before the summer of 2016, while the fitting out of two replacement classrooms also made good progress. After almost two years' hard work to revamp the entire primary programme, trial classes incorporating new animations and videos with the new teaching technologies were conducted intensively during the year. Feedback from teachers was vital in ensuring that the programmes are tailored to students' needs. We are all looking forward with excitement to the launch of the new primary programme in September 2017.

概要

對於 LEAP 來說, 二零一五 / 一六學年是 令人興奮又忙碌的一年, 我們有多項重要 計劃正在密鑼緊鼓地進行中。

於本學年內,我們的預防藥物教育課程 破紀錄地服務超過十萬七千七百三十 名五至十五歲的學生,當中包括八 萬四千三百三十三名小學生,一萬 八千五百三十七名中學生及四千八百六十 名特殊學生。在 LEAP 團隊的不懈努力 下,我們繼續達成服務全港百分之二十五 小學生的目標。同時,我們也為全港百分 之十一的中學生提供課程,超越了原訂百 分之十的目標。

LEAP 的工作在過去幾年有重大的發展, 在服務範圍及受惠人數兩方面均不斷增加。鑑於近年小學生人口激增,LEAP將 會努力提升成本效益,以便在服務更多學 生之餘,讓機構維持温和的發展步伐,令 團隊能累積更多的經驗。

在二零一六年夏季前,我們已經為所有流 動課室及班房課程配置了最新教學科技, 兩所用作替換的新流動課室的裝修工程亦 進行得非常順利。經過接近兩年的努力, 小學課程的改革工作大有進展,新製作的 教學動畫、影片及教學科技已結合到新課 程當中,緊密地進行試教工作,以廣泛收 集教師的意見,讓課程能滿足學生的需 求。我們非常期待全面革新的小學課程在 二零一七年九月正式啟用。



In order that LEAP continues to extend its student reach, we have been lucky enough to secure the generous support of many like-minded partners in the last few years to ensure its sustainable development. Projects sponsored by the Tobacco Control Office (TCO), Beat Drugs Fund, Lee Hysan Foundation and Chow Tai Fook Charity Foundation, for example, have helped LEAP to outreach its service to many more schools and students who might have otherwise been deprived of the opportunity because of limited resources.

With underage drinking emerging as a concern, LEAP worked on raising awareness of the problem and promoting the importance of alcohol education for young people and their parents during the year. LEAP was especially pleased to know that the government is taking action in controlling the

sale of alcohol to people under the age of 18 and to learn of the publicity campaign launched by the Department of Health in late 2016. We are more than ready to intensify our efforts in alcohol prevention education as a cooperative effort.

Looking ahead, LEAP

is preparing to offer students a revision of the entire LEAP experience. Working with all sectors of the community, including government and non-government organizations, schools, teachers and parents, LEAP will continue its efforts to excel in its programmes and reach more students in order to ensure a healthy, drug-free society for the next generation. 過去幾年,我們幸運地獲得許多志同道合 夥伴的慷慨支持,讓LEAP可持續發展, 繼續服務更多學生,當中包括控煙辦公室 (控煙辦)、禁毒基金、利希慎基金和周 大福慈善基金等,他們的資助讓更多學校 和學生可以突破資源限制以受惠於LEAP 的課程。

Programme Review

In the 2015/16 academic year, LEAP served 279 schools, including kindergartens, primary, secondary and special needs schools. Our team of 22 educators worked tirelessly to ensure that our education programmes are of the highest quality.

The "LEAP without Boundaries" project (Phase 1), funded by the Lee Hysan Foundation and Chow Tai Fook Charity Foundation, has been successfully implemented for two years since September 2014. LEAP again surpassed the annual targets of reaching 4,500 students and 200 parents in the 2015/16 academic year. Thanks to the generosity of both foundations, Phase 2 of the project commenced in September 2016, and will benefit an additional 4,500 students and 200 parents for six consecutive years.

The Tobacco Control Office (TCO) continued to provide funding for the complimentary delivery of LEAP's smoking prevention programmes to Primary 5 students and junior secondary students. In the 2015/16 academic year, LEAP provided free anti-smoking programmes to 9,550 primary and 7,772 secondary students. LEAP's smoking prevention programmes aim to increase students' understanding of the dangers of smoking and the marketing strategies of tobacco companies, as well as help them develop effective skills to deal with peer pressure. The three-year Beat Drugs Fund project for the free delivery of our parent programme was completed in August 2016. The project

aimed to reach 12,500 parents through 600 sessions. LEAP surpassed this target, reaching a total of 21,558 parents at 629 workshops during the project. LEAP's parent programme aims to help parents play a more active role in drug prevention by equipping them with effective parenting and communication skills so they can nurture a drug-free family.

LEAP also serves the international and non-Chinese speaking community on a daily basis. Thanks to a donation from the Hong Kong Racehorse Owners Association Charitable Foundation, some 1,000 non-Chinese speaking ethnic minority students attending English Medium Instructor (EMI) schools benefitted from LEAP's English programme in the 2015/16 academic year, regardless of resource restrictions. 國際學校及非華語學生也是 LEAP 的服務對象。感謝香港馬主協會慈善基金的慷慨捐助,在二零一五/一六學年,讓一千名就讀於英文授課 (EMI) 學校的非華語少數族裔學生能突破資源限制,參與 LEAP的英語課程。



Programme Development

LEAP took steps to prepare for a full revamp of its Chinese and English primary programme in 2015. After almost two years of painstaking work, significant progress was noted in the year under review. New videos and animations were produced, while trial classes began before the 2016 summer break, followed by the production of programme songs and printed materials. As the new academic year starts in September 2017, LEAP will be ready to offer six brand new programmes for Primary 1 to Primary 6 students.



Over and above its core primary programme, LEAP offers additional extension programmes that explore specific topics including personal image, cyber choices and emotions with students. During the year, the team revamped the emotions extension programme to ensure that the messages come across clearly for the maximum benefit of students. 課程發展

Thanks to a grant from the Hong Kong Jockey Club Charities Trust, LEAP was able to proceed with its plan to replace two mobile classrooms and extend its latest teaching technologies to all its classrooms in 2016. In addition, the new teaching AR (Augmented Reality) and Kinect technologies have also been made available for the in-class programmes since September 2016 to provide a new learning experience for more students. The new technological activities have been very well received by both students and teachers.



In preparation for the launch of the new mobile classroom for the special needs programme, a number of tailor-made activities adopting the new teaching technologies were developed during the year to provide helpful solutions for students with developmental disabilities. These were designed with various objectives such as to help students to learn and identify different parts of the body and to improve their handeye coordination. Promoting Awareness

Mobile Classroom Design Competition

To celebrate the launch of its new special needs mobile classroom in March 2017, LEAP organized a design competition for the exterior of the classroom in 2016. There was a great response to the competition, with some 560 special needs students participating in two categories for primary and secondary students respectively. The winning designs from each category were modified to be applied to the exterior panels of the new mobile classroom. LEAP would like to thank all the participants and their schools for their enthusiastic support.

Supporting Tighter Alcohol Control

As an organisation dedicated to the prevention of drug abuse among young people, LEAP seeks to play its role in fostering a social environment that discourages the use and availability of drugs. During the year, LEAP wrote to the South China Morning Post twice about the problem of student drinking so as to raise public awareness and also to promote the importance of alcohol prevention education for young people and their parents.

We were therefore particularly pleased when in December 2016, the Department of Health officially launched a largescale publicity campaign entitled "Young & Alcohol Free" to step up efforts to combat underage drinking. The government has also begun consultations on its proposal to prohibit the commercial sale and supply of alcohol to persons aged below 18. Cheer for LEAP Scholarships : Cooking Contest

To encourage Hong Kong primary students to eat a healthy diet and to promote parent-child relationships, LEAP once again organized the Cheer for LEAP Scholarships, with funding from Dah Chong Hong Holdings. During the 2015/16 academic year, students were asked to partner with a parent or guardian to create a family-friendly healthy recipe. Selected finalists were then invited to prepare their recipes at a cooking competition, when the winners were decided. LEAP would like to thank Dah Chong Hong Holdings sincerely for its continuous support, helping us to promote a healthy lifestyle since September 2013.

LEAP - Who We Are 生活教育活動計劃



Established in 1994, Life Education Activity Programme (LEAP) is a registered charity that provides internationally recognized health awareness and drug prevention programmes for primary and secondary students. It helps students establish a healthy lifestyle and become aware of the dangers of drugs, including tobacco and alcohol. LEAP's programmes are endorsed by the Hong Kong SAR Government's Education Bureau, the Narcotics Division of the Security Bureau and the Tobacco Control Office of the Department of Health. The Hon. C. Y. Leung, GBM, GBS, JP, the Chief Executive, is our patron.

Life Education originated in Australia. The first Life Education Centre was established in 1979 by the Reverend Ted Noffs in Sydney. The concept spread throughout Australia and internationally. Today Life Education also operates in Australia, Barbados, Cyprus, Finland, Hong Kong, Hungary, Macau, New Zealand, the UK and USA.

Over the last 20 years, our Primary Programme has been taken to schools in specially designed mobile classrooms, which can be driven all over the territory. LEAP also runs a Secondary Programme, a Special Needs Programme and a Parent Programme aimed at equipping parents with skills 生活教育活動計劃(LEAP)於一九九四 年在香港成立,是一個註冊慈善機構, 專為中、小學的學生提供一套國際認可 的健康教育及預防藥物濫用課程,旨在 讓他們明白到健康生活的重要及濫用藥 物,包括煙草和酒精的危險。課程獲教 育局、保安局禁毒處及衞生署控煙辦公 室的認可。

過去二十年,LEAP以設計獨特之流動課 室將生活教育課程帶進全港各區的小學。 LEAP亦有推行中學課程和特殊教育課 程,以及一套家長教育課程,以裝備家 長協助子女建立正確的價值觀,抗衡藥 物的引誘。 to help their children establish correct values and to prevent substance abuse.

LEAP's mobile classrooms are our centre stage and make our programmes unique. They provide a relaxed environment for youngsters to enjoy the programme and become involved in discussions and role-play. Our specially trained educators make use of a modern audio-visual system, illuminated models of the human body, a "talking brain" and games. LEAP's mascots Harold the Giraffe and Holly the Horse reinforce healthy living messages by talking and singing with the children. Our aim is to provide a step-by-step approach to learning about the body and how drugs affect it. Role-play helps develop social competency skills that enable children to make responsible decisions and to say "No" to drugs without losing friends or face.

In 2014 LEAP introduced two new mobile classrooms equipped with Augmented Reality (AR) and Kinect technologies. Following technology retrofits to our mobile classrooms in 2016, our fleet of classrooms was enhanced further when two new replacement classrooms came into operation in March 2017. LEAP is now fully equipped with the AR/Kinect teaching technologies, allowing students to enjoy an exceptional learning experience combining technology, fun and knowledge. With a fleet of nine mobile classrooms and a static centre, LEAP has attained its strategic goal of reaching 25 per cent of the primary student population. 從一開始,流動課室已是 LEAP 的重要舞 台,令 LEAP 的預防藥物濫用課程獨一無 二。生活教育中心設計新穎獨特,為學生 營造輕鬆愉快的學習環境,令他們能更投 入課堂討論及角色扮演等教學活動中。受 過特別訓練的教育幹事們,利用中心內的 先進影音器材、會發亮的人體模型、會説 話的腦袋及各式互動遊戲授課。而 LEAP 的吉祥物「長頸鹿哈樂」及「小馬凱莉」 更會在課程期間跟學生説笑及唱歌,從而 進一步鞏固健康訊息。LEAP 透過循序漸 進的教學方式,讓學生認識人體的結構及 藥物對它的影響;而角色扮演更能協助學 生建立社交技巧,懂得如何作出正確的抉 擇,有信心地拒絕煙酒等藥物並同時保存 自尊及友誼。

LEAP 於二零一四年率先添置了兩所增設 了全新擴增實境(AR)和體感(Kinect)科技 的流動課室,並於二零一六年為其他流動 課室增設這些嶄新的教學科技。於二零 一七年三月,LEAP的兩所用作替換的全 新流動課室啟用,LEAP的全部流動課室 現已配備好 AR 及 Kinect 教學科技,讓學 生體會兼具科技、知識與樂趣的學習經 驗。LEAP 現有九所流動教室和一所固定 教育中心,並成功達致每年服務全港百分 之二十五小學生的目標。



FOR THE YEAR ENDED 31 DECEMBER 2015

1. GENERAL INFORMATION

Life Education Activity Programme (the "Company") is a registered charity, incorporated in Hong Kong with liability limited by guarantee. The address of its registered office is Unit 107-113, G/F., Lok Yiu House, Lai Yiu Estate, Kwai Chung, New Territories, Hong Kong.

The Company was engaged in providing educational programmes during the year.

2. BASIS OF PREPARATION

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). HKFRSs comprise Hong Kong Financial Reporting Standards ("HKFRS"); Hong Kong Accounting Standards ("HKAS"); and Interpretations. These financial statements also comply with the requirements of the Hong Kong Companies Ordinance (Cap. 622).

3. ADOPTION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS AND REQUIREMENTS

(a) Application of new and revised HKFRSs

In the current year, the Company has adopted all the new and revised HKFRSs issued by the HKICPA that are relevant to its operations and effective for its accounting year beginning on 1 January 2015.

(b) New and revised HKFRSs in issue but not yet effective

The Company has not early applied new and revised HKFRSs that have been issued but are not yet effective for the financial year beginning on 1 January 2015. The directors anticipate that the new and revised HKFRSs will be adopted in the Company's financial statements when they become effective. The Company is in the process of assessing, where applicable, the potential effect of all new and revised HKFRSs that will be effective in future periods but is not yet in a position to state whether these new and revised HKFRSs would have a material impact on its results of operations and financial position.

(c) New Hong Kong Companies Ordinance (Cap. 622)

The requirements of Part 9 "Accounts and Audit" of the new Hong Kong Companies Ordinance (Cap. 622) came into operation during the financial year. As a result, there are changes to presentation and disclosures of certain information in the financial statements.

4. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared under the historical cost convention.

The preparation of financial statements in conformity with HKFRSs requires the use of certain key assumptions and estimates. It also requires management to exercise its judgement in the process of applying the Company's accounting policies.

The significant accounting policies applied in the preparation of these financial statements are set out below.

(a) Property, plant and equipment

Property, plant and equipment are stated in the statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. All other repairs and maintenance are expensed in the income and expenditure account during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost over the estimated useful lives on a straight line basis. The principal annual rates are as follows:

Classroom and production related cost	12.5%
Classroom equipment, technologies/artworks	20%
Programme	20%
Office equipment	33.33%
Office decoration	33.33%
Motor vehicles	33.33%
Promotional materials	33.33%

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting date.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

(b) Resale items

Resale items represent souvenirs purchased for resale and are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs necessary to make the sale.

(c) Recognition and de-recognition of financial instruments

Financial assets and financial liabilities are recognised in the statement of financial position when the Company becomes a party to the contractual provisions of the instruments.

Notes to the Financial Statements 財務報表附註

Financial assets are de-recognised when the contractual rights to receive cash flows from the assets expire; the Company transfers substantially all the risks and rewards of ownership of the assets; or the Company neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control of the assets. On de-recognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received and the cumulative gain or loss that had been recognised in other comprehensive income is recognised in profit or loss.

Financial liabilities are de-recognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability de-recognised and the consideration paid is recognised in profit or loss.

(d) Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less allowance for impairment.

(e) Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value.

(f) Financial liabilities

Financial liabilities are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability under HKFRSs. The accounting policies adopted for specific financial liabilities are set out below.

(i) Other payables

Other payables are stated initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(g) Revenue recognition

The Company relies on sponsorship from major corporations to cover the majority of the costs of running its programmes. Sponsorship and Educator subsidies are recognised as income evenly over the periods specified by the donors. Amounts relating to future accounting periods are shown in the balance sheet as advance funding. Other income reflects the results of fund raising for capital equipment and future contingencies and is recognised upon receipt.

Interest income is recognised on a time-proportion basis using the effective interest method.

(h) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii)Pension obligations

The Company contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Company and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to income and expenditure account represents contributions payable by the Company to the funds.

(iii)Termination benefits

Termination benefits are recognised at the earlier of the dates when the Company can no longer withdraw the offer of those benefits and when the Company recognises restructuring costs that involves the payment of termination benefits.

(i) Impairment of non-financial assets

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the statement of profit or loss to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the cash-generating unit.

Value in use is the present value of the estimated future cash flows of the asset/cash-generating unit. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/cash-generating unit whose impairment is being measured.

(j) Impairment of financial assets

At the end of each reporting period, the Company assesses whether its financial assets are impaired, based on objective evidence that, as a result of one or more events that occurred after the initial recognition, the estimated future cash flows of financial assets have been affected.

For all financial assets, the carrying amount is directly reduced by the impairment loss.

For financial assets measured at amortised cost, if the amount of the impairment loss decreases in a subsequent period and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed through profit or loss. However, the reversal must not result in a carrying amount that exceeds what the amortised cost of the financial asset would have been had the impairment not been recognised at the date the impairment is reversed.

(k)Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Company has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow

of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

5. FINANCIAL RISK MANAGEMENT

The Company's activities expose it to a variety of financial risks: liquidity risk and interest rate risk. The Company's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Company's financial performance.

(a) Foreign currency risk

The Company has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in Hong Kong dollars. The Company currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Company will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

(b) Credit risk

The carrying amount of the bank balances and other receivables, included in the statement of financial position represents the Company's maximum exposure to credit risk in relation to the Company's financial assets.

The Company has no significant concentrations of credit risk.

The credit risk on bank balances is limited because the counterparties are banks with high credit-rating assigned by international credit-rating agencies.

(c) Liquidity risk

The Company's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.

The maturity of the Company's financial liabilities at 31 December 2015 and 2014 is less than one year.

(d) Interest rate risk

The Company's exposure to interest-rate risk arises from its bank deposits. These deposits bear interest at variable rates varied with the then prevailing market condition.
